#### Call for tender "European network for medical and veterinary entomology"

The European Centre for Disease Prevention and Control (ECDC) has published the call for tender "European network for medical and veterinary entomology" that also concerns EFSA.

The main objectives of the framework contract are:

- to consolidate the existing European network of medical and veterinary entomologists (VectorNet),
- to provide scientific support to ECDC and EFSA for their assessments on vectors and vectorborne diseases risk, prevention and control,
- to define and/or update the geographical distribution, abundance and seasonality of targeted arthropod vectors in the EU/EEA, the EU Enlargement countries, the European Neighbourhood Policy partner countries, and possibly some EU overseas countries and territories and EU outermost regions,
- to contribute to capacity building on vectors and vector-borne diseases.
