24th & 25th September 2018 at the Austrian Agency for Health and Food Safety (AGES), Vienna, Austria Deadline for registration: 30/5/2018

The Austrian Agency for Health and Food Safety (AGES) is organizing a workshop on "Interactive Data Visualization on the Web using R". The workshop will be held in Vienna (Austria) on the 24th and 25th of September 2018 and is funded by EFSA through an action grant. Costs for travel and accommodation will be reimbursed by EFSA.

The event will allow researchers/programmers from European Risk Assessment Agencies to discuss technological and communicational aspects of interactive web visualization with like-minded colleagues. Participants will have the opportunity to present their own projects or experiences in the field in short presentations. The workshop mainly focuses on the technical implementation using R and is intended for experts who

- * are familiar with R programming,
- * have experience in interactive visualisation with R and/or
- * have experience in interactive web visualisation using other tools (e.g. JavaScript, Python) and/or
- * have expertise in presenting scientific results on the web, particularly in how to efficiently visualise and communicate results.
