The European Commission asked EFSA to carry out a rapid assessment on the risks for public health related to the presence of mineral oil aromatic hydrocarbons (MOAH) in infant formula and follow-on formula. This follows the recent detection by NGO Foodwatch of MOAH in certain batches of infant formula in France, Germany, and the Netherlands.
