#### Call for expression of interest for members of Horizon Europe Mission Boards

Following the partial political agreement reached in April 2019 between the European Parliament and the Council on **Horizon Europe**, the 2021 – 2027 EU Framework Programme for Research and Innovation, the European Commission is already preparing the steps towards the implementation of this programme. This is done while pending agreement on its budget as part of the general agreement on the Union's multi-annual financing framework.

One of the main novelties of Horizon Europe is the development and implementation of ambitious 'Research and Innovation Missions'. These aim at maximising the impact of the R&I programme and demonstrate its relevance for society and citizens.

The **five 'mission** <u>areas'</u> agreed for the implementation in the first years of Horizon Europe are as follows:

- Cancer
- Adaptation to Climate Change, including Societal Transformation
- Healthy Oceans, Seas, Coastal and Inland Waters
- Climate-neutral and Smart Cities
- Soil Health and Food

On 13 May 2019 the Commission launched a <u>call for expression of interest</u> for members of the five Mission Boards. Out of those mission areas, Mission Boards will help specifying, designing and implementing the specific missions for Horizon Europe. The Commission is looking for a broad mix of experts from industry and innovation, research, policy making, practitioner organisations and also from end users, which are appointed in a personal capacity and have a deep commitment to the success of the missions.
