### ***PUBLIC CONSULTATION: draft scientific opinion as regards maximum levels of cross-contamination for 24 antimicrobial | 18 November 2020***

Dear Focal Points,

EFSA's Panel on Biological Hazards (BIOHAZ) has launched an open consultation on several sections of the draft scientific opinion on "maximum levels of cross-contamination for 24 antimicrobial active substances in non-target feed". These sections include the description of the methodology proposed to answer the term of reference 1 of the mandate, which is related to antimicrobial resistance development, the uncertainties associated with it, and the data gaps/other considerations identified.

Additional sections of the draft opinion are shared to provide the background, contextualize the methodology, and to provide an example of the assessment if the methodology would be used (e.g. tetracyclines). These additional sections are provided only for information and are not submitted for consultation.

## ***Public consultation on the draft scientific guidance for the preparation of applications on smoke flavouring primary products - 16 November 2020.***

This document provides guidance to applicants on the data to be included in applications for the authorisation of new smoke flavouring primary products, as well as for the modification or for the renewal of existing authorisations, submitted under Articles 7, 11 and 12 of Regulation (EC) No 2065/2003.

Please note that the deadline for interested parties to submit written comments is **16 November 2020**.

We would like to draw your kind attention also to the advertised **Technical hearing on the draft scientific guidance on smoke flavouring primary products** scheduled on **5 November** (during the public consultation period) as a virtual meeting.

This event is aimed at exchanging views on the content of the draft guidance document and to discuss the comments raised during the public consultation. ### ***EFSA's scientific opinion "Risk to human health related to the presence of PFAS in food"***

We are pleased to inform you that EFSA published today a **scientific opinion on the risks to human health arising from the presence of perfluoroalkyl substances, or PFAS, in food.**

Experts set a new safety threshold for the main PFAS, that accumulate in the body, a group tolerable weekly intake (TWI) of 4.4 nanogram per kilogram of body weight per week.

The scientific opinion addresses the feedback received from scientific organisations, citizens, and competent authorities in Member States during a two-month consultation period between February 2020 and April 2020.

## ***Final Report of the AF TF on Data Collection and Data Modelling -published online***

We are pleased to inform you that the [final report of the Advisory Forum Task Force on Data Collection and Data Modelling](#) has been published under EFSA Supporting publications on Wiley Online.

During the 67th AF meeting (February 2018) a **Task Force on data-related issues** was agreed to be created. The Task Force was composed by AF members (or their representatives), chaired by Hungary and supported by EFSA. The main objectives of the Task Force were to review, from a strategic perspective, the data collection and reporting processes, the data model and IT infrastructure that are used in the sharing of data between data providers and EFSA, and to formulate recommendations at a strategic level. The objectives of the Task Force were in connection to EFSA's data-related activities and are presented in the final report of the Task Force.

The final report and the recommendations of the Task Force are the result of discussions at 14 meetings over the period of September 2018 to July 2020. The report also contains the resulting vision of a future ideal food safety system, as well as conclusions and recommendations for identified quick wins, short- to medium-term and long-term actions.
