Pre-Notification on EFSA's 2020 Thematic Grant call (Microbiomes - Gastro-intestinal and Environmental and Plant Health)

# Public Consultation on data collection on products or materials to present a risk to transmit ASF virus

We would like to inform you that EFSA's Panel on Animal Health and Welfare (AHAW) has launched an <u>open consultation</u> on a draft data section of the scientific opinion on risk assessment of African Swine Fever and the ability of products or materials to present a risk to transmit ASF virus. This draft section lists data on the ability of ASFV to survive and remain viable in different matrices and information on matrix production/ processing parameters that allow to understand if the production/ processing of the matrix would allow the virus to remain viable, should the matrix have been contaminated with ASFV before production/ processing.

Interested parties are invited to submit written comments by 28 February 2020. Please use the <u>electronic template provided</u> to submit comments and refer to the line and page numbers. To submit additional data to support your comments or files, there is an upload function available in the tool (for a maximum size of 1Mb file). Otherwise you can also contact the **ALPHA Unit** functional mailbox <u>alpha@efsa.europa.eu</u>.

Please note that comments will not be considered if they:

- are submitted after the closing date of the consultation (Friday, 28.02.2020);
- are presented in any form other than what is provided for in the instructions and template;
- are not related to the contents of the document;
- contain complaints against institutions, personal accusations, irrelevant or offensive statements or material;
- are related to policy or risk management aspects, which are out of the scope of EFSA's activity.

# Council of Europe: Food contact materials and articles: new documents for consultation

In the framework of its task to develop and strengthen standards and policies to improve the health protection of consumers, the <u>European Committee for Food Contact Materials and Articles (Partial Agreement) (CD-P-MCA)</u>, has elaborated a set of general technical provisions to be appended to an upcoming Council of Europe resolution on food contact materials and articles and specific provisions for paper and board food contact materials and articles.

The two documents:

- <u>Guiding Principles for Food Contact Materials and Articles</u> (technical appendix to the resolution on food contact materials and articles), and
- Technical Guide on Paper and Board Materials and Articles for Food Contact

are open for consultation by all concerned parties (national authorities, control laboratories, business operators) from 5 February 2020 to 16 March 2020.
