Allergenicity assessment of GM plants: stakeholders to support working group - call for expression of interest - deadline 15 August 2020

We would like to inform you that, in light of successful past collaboration with stakeholders and the great interest in the subject of GM plants, EFSA is setting up a stakeholder consultative group to support its upcoming work on the allergenicity assessment of genetically modified (GM) plants.

The group will be consulted at various stages during the process and will provide input to the EFSA scientific working group in charge of the activity.

<u>Experts from Member States will be also involved in the consultation group</u>. The group will be invited to online (owing to the current sanitary situation) meetings of the Allergenicity Working Group and to a workshop that is scheduled to take place in spring 2021.

Nominations for membership of the stakeholder group will be accepted from registered EFSA stakeholder organisations as well as non-registered bodies with an interest in the area of allergenicity assessment.

We would like to inform you that EFSA's Scientific Committee has launched an open consultation on its draft EFSA Statement on the derivation of Health-Based Guidance Values (HBGVs) for regulated products that are also nutrients.

This draft approach aims to harmonise assessments of the intake of these nutrients, the potentially hazardous properties of excessive intakes, and the overall risks for consumers. EFSA is holding a public consultation on the draft so that other scientific experts, organisations with an interest in the food chain, and members of the public can submit their views on the Scientific Committee's proposal.

On behalf of the Organizing Committee of the event "Modern technologies to enable response to crises: Next Generation Sequencing to tackle food-borne diseases in the EU", we hereby inform you that the Conference will be held <u>online</u> on **September 25, 2020** (same date as per previous communication of postponement) due to the ongoing measures to reduce the spread of COVID-19 pandemic.

Please find below the original received message:

"The COVID-19 pandemic is changing the way we interact and the experiences we are all used to, when it comes to the scientific discussions. The concept of networking is also changing and revolving almost uniquely around the technology to connect people. We still believe that gathering people together is what can make the difference and decided to maintain the conference alive. However, considering the uncertainty on the traveling capacity and the necessity of people to feel safe we transformed the event into an online conference. Due to the technical need of keeping the event flowing smoothly the agenda has been shortened but retained the major points to fire the discussion over the implementation of genomic surveillance and monitoring of the food-borne diseases.

We'll talk about the standard that NGS aims to be and the major hindrances together with all the main actors that envisioned the development of a European system for genomic data collections from foodborne pathogens and AMR.

The event aims at being immersive and thus be prepared to discuss and to share your opinions, through the use of an online platform that will allow to collect and aggregate inputs from the plenum on specific topics in real time.
