UPDATE: Public consultation on the draft scientific guidance for the preparation of applications on smoke flavouring primary products

We would like to inform you that EFSA has published a **public consultation on the draft scientific guidance for the preparation of applications on smoke flavouring primary products**.

This document provides guidance to applicants on the data to be included in applications for the authorisation of new smoke flavouring primary products, as well as for the modification or for the renewal of existing authorisations, submitted under Articles 7, 11 and 12 of Regulation (EC) No 2065/2003.

Please note that the deadline for interested parties to submit written comments is 16 November 2020.

We would like to draw your kind attention also to the advertised **Technical hearing on the draft scientific guidance on smoke flavouring primary products** scheduled on **5 November** (during the public consultation period) as a virtual meeting.

This event is aimed at exchanging views on the content of the draft guidance document and to discuss the comments raised during the public consultation. The scope of this Opinion covers viable synthetic biology microorganisms (SynBioMs) expected to be deliberately released into the environment. The evaluation was based on: (i) horizon scanning of published information, (ii) gap analysis of existing guidelines covering the scope of this mandate, and (iii) future outlooks.
