### Calls

Call for Expression of Interest - Technical group on machine learning, natural language processing and data mining | Deadline: 29 March 2021

EFSA is currently evaluating the possibility to set-up an <u>interest group of data scientists</u> aimed at sharing knowledge and views from a technical perspective on machine learning, natural language processing and data mining.

#### **Background of the initiative**

Natural language processing tools and machine learning as subdomains of AI, have a large potential in helping to automate various parts of the risk assessment process. IT tools and approaches in this area are rather independent of the concrete processes and organization, as they are on the lower level of human written text and data. This makes them applicable across organizations.

#### Objective of the initiative

An enhanced collaboration on this topic will ensure to avoid duplication of work and to benefit from a two-way learning process, identifying where and how the application of such kind of tools can be highly advantageous in food safety risk assessment.

#### **Skills needed:**

Experience in applying natural language processing, machine learning and other data science tools in the context of food safety risk assessment.

Save the date | "Building trust: Poster presentations from each corner of the world!"

Further to the webinar *The fragility of trust in regulatory science: challenges, opportunities and future prospects* which took place in October 2020, the European Food Safety Authority (EFSA) and the US Food and Drug Administration (FDA) would like to continue the journey towards the creation of an interinstitutional community of practice, where we can share best practices and experiences on building and maintaining public and stakeholder trust.

What do we propose as the next step? We would like to organise a virtual poster exhibition, built on your voluntary contributions, and based on your experience with building and strengthening trust-based relationships with external stakeholders. You are invited to submit a description to present a process or project meeting the guidelines. All descriptions will be presented in the format of a poster in a virtual poster session. The virtual exhibition will remain open for one month; participants will be in the position to familiarise with the projects and engage with the poster authors. From the submitted posters, FDA and EFSA will select some particularly meaningful projects for an oral pitch during the closing event, where participants will listen to the poster author's first-hand experiences and then reflect collectively on them.

All participants have until the 14<sup>th</sup> of April to decide if they will send a poster or not and to submit the description. Posters will then be published on a virtual platform, where participants will be able to see, comment and contact the authors. The virtual exhibition will remain open from 14<sup>th</sup> of May to 16<sup>th</sup> of June. More information on how to upload a poster in the platform and how to visit the virtual exhibition will be disclosed in due course.

Following the poster exhibition, we are planning to organise a digital meeting on *Building trust: Poster presentations from each corner of the world!* to be held on the 16<sup>th</sup> of June to present and debate some posters at the online meeting.

You may also choose to participate at the exhibition and the final meeting without submitting a poster. The number of posters will not be limited.

# Webinar: MetaPath – how to complete MSS composers for pesticides metabolism studies, 29 and 31 Mar. at 9:30 (CET) | Deadline: 26/3/2021

We would like to inform you on the **MetaPath webinars** that will guide participants on **how to complete MSS composers for pesticides metabolism studies**. In the context of the Transparency Regulation, which amends the General Food Law (GFL), EFSA has new requirements for capturing, managing, handling and distributing data on plant protection products (PPP). These changes require the **specification of data formats** for regulated product dossiers and allow documents to be submitted, searched, copied and printed, while ensuring compliance with legal requirements. It has been decided to use **IUCLID formats** and the **IUCLID tool** (managed by the European Chemicals Agency, ECHA Cloud platform) for data preparation, electronic submission and management of pesticide dossiers.

The webinar is open to potential applicants, business operators and any interested stakeholders.

There are scheduled **two connected sessions**:

1<sup>st</sup> session: How to complete MSS composers for pesticides plant metabolism studies, on Monday **29<sup>th</sup> March 2021**, 09:30-12:30/14:00-17:00 (CET)

2<sup>nd</sup> session: **How to complete MSS composers for pesticides livestock and rotational crop metabolism studies**, on Wednesday **31**<sup>st</sup> **March 2021**, 09:30-12:00 (CET)

Note: **2**<sup>nd</sup> session builds on the training provided in **1**<sup>st</sup> session. Registrations are therefore for both sessions and participants will be encouraged to practice using the MSS composer software between the two sessions.
