Reminder: Call for interest for experts in the field of biomarkers of effects | Deadline: 7th December 2022

EFSA is looking for experts to participate in preparatory work or support the Working Group that will be established to prepare a guidance document on biomarkers of effect.

EFSA aims to prepare guidance documents to support the Panels and Units when establishing a Health Based Guidance Value in the absence of clear evidence of adversity or overt toxicity of a chemical. For this reason, a dialogue has been established with scientists in and outside the EU, with International Organisations and with other scientific advisory bodies, to learn from existing experiences, to gather information on the approaches taken so far, to collect views and recommendations on possible ways and to help EFSA to shape its future work in this area. To continue the scientific discussion started at the thematic workshop on "Biomarkers of effects" held in September 2022 and to perform preparatory work in specific sub-areas that will support the preparation of the guidance document, EFSA is inviting MSs to nominate experts with the scientific background relevant for the topic to be addressed.

- Lot 1: for fruit-bearing vegetables
- Lot 2: for cereals and fibre crops
- Lot 3: for grape, berries and exotic fruits
- Lot 4: for palms and ornamentals.

You may submit a proposal for one or more lots. In case you decide to apply for more lots, a separate proposal for each lot must be provided.

This call for proposals, is the type of grant based on achievements of results (milestones/indicators). You can find more details as specific objectives of the call in the call documents (ref. the link above).

The deadline for submission of proposals is **15 March 2023.**

The Call intends to fund the placement of 15 fellows by awarding grants to **consortia** made of **two** Art. 36 List organisations from two different MS, Iceland and Norway:

- ✓ one acting as **hosting site** and responsible for the training of the fellow, and
- ✓ the other as **fellow sending organisation**, identifying a fellow to be trained.

The Funding and Tender Opportunities portal includes a feature allowing for the search of partners. However, to further facilitate the **creation of consortia**, please contact your <u>National Focal Point</u> expressing your interest in this call, either as a hosting site or as a fellow sending organisation. Note that the same organisation can act as both in different consortia.

Organisations can make use of existing joint projects and partners from former projects and EFSA/EU grants. Some of the currently existing large EU projects could be a **good starting point** for organisations to search for partners: For example, <u>projects involving EFSA</u>, EFSA partnering grants, etc. always keeping in mind the need to avoid potential EU double funding.

Workshop on EFSA's updated Guidance on the use of the benchmark dose approach in risk assessment - 15-16 February 2023 | deadline: 9 January 2023

EFSA is holding a workshop to disseminate the revised methodology for benchmark dose (BMD) analysis in EFSA's updated Guidance document and to support its implementation in the R4EU BMD analysis platform.

The event takes place in the afternoon of 15 February and in the morning of 16 February, and is divided in two parts:

- 1. Presentation of the new guidance, changes to the previous version, and EFSA's recommended approach for BMD analysis.
- 2. Illustration of the new approach, using the EFSA BMD analysis platform with pesticides-related case studies.

Risk assessors and all stakeholders involved or interested in the use of the benchmark dose (BMD) approach in risk assessment are invited to attend.

EFSA's Update of re-evaluation of sulfur dioxide-sulfites (E220-228)

EFSA has published the scientific opinion on the "Follow-up of the re-evaluation of sulfur dioxide (E 220), sodium sulfite (E 221), sodium bisulfite (E 222), sodium metabisulfite (E 223), potassium metabisulfite (E 224), calcium sulfite (E 226), calcium bisulfite (E 227) and potassium bisulfite (E 228)".

It is accompanied by a news story "<u>Sulfites: safety concern for high consumers, but data lacking</u>" (also available in German, French, Spanish and Italian).

Gaps in toxicity data meant the extent of certain adverse health effects could not be confirmed.

EFSA has updated the re-evaluation of eight food additives (sulfur dioxide - SO2 and seven sulfites) used in wine and other foodstuffs, and sets a margin of exposure (MOE), withdrawing the temporary ADI set in 2016 due to insufficient data.

The MOE approach was used because uncertainties were identified in the evidence from the updated literature review, in particular surrounding possible adverse toxicological effects, adding to the previously identified data gaps in the toxicity data.
