EFSA grant - GP/EFSA/PLANTS/2022/01 - "Cooperation with EFSA in the area of Cumulative Risk Assessment from dietary exposure to pesticides" | DL 29/04/2022

We would like you to support EFSA in promoting the call for proposals (grant): **Cooperation with EFSA** in the area of Cumulative Risk Assessment (CRA) from dietary exposure to pesticides - Ref GP/EFSA/PLANTS/2022/01

This call for proposals, is in a new type of grant based on achievements of results/deliverables. The main objective of the call is to **implement the CRA process in the form of a cooperative activity between EFSA and competent national organisations.** This would optimise the experience sharing in EU, and therefore contribute to the achievement of the EFSA strategic objective 'Building the EU's scientific assessment capacity and knowledge community' while ensuring consistency of the outcomes.

This Call for proposals aims therefore to conclude a Framework Partnership Agreements (FPA) preferably with a consortium of Article 36 organisations for the performance of the tasks described in the call specifications.

Please note that the deadline for submission of proposals is 29 April 2022
