The deadline for submission of proposals is Thursday 3rd November 2022 (12:30 CET).

Please note that to pursue of stronger engagement of the Member States competent organisations active in the core tasks of EFSA, this open grant call has eight lots - covering various competence area commonly applicable to these four regulatory domains: **food enzyme, food additives, food flavourings** and **feed additives**. This call for proposals, is in a new type of grant based on achievements of results/deliverables supporting EFSA directly in its mission. Proposals can be submitted by one eligible organisation or **by consortia** of eligible organisations for **one** or **more lots**.

Finally, it will provide practical guidance on lessons-learnt and essentials to take account of when submitting confidentiality requests.

Editorial on EFSA's preparedness

We inform you that the implementation of the Transparency Regulation (Regulation EU 2019/1381) has provided EFSA with the opportunity to allocate dedicated resources to scientific themes in its regulatory areas, in a coordinated manner with larger EU and Member States research and innovation programmes.

A number of themes have been selected since 2020. These have been identified based on known (methodological) knowledge gaps and as areas that need to be developed further so that EFSA is prepared for future regulatory challenges. For each theme roadmaps for action are developed which provide a full understanding on ongoing activities, knowledge gaps, societal interests and concerns as well as collaboration opportunities and potential partners.

To fill in the knowledge gaps, specific high-value project calls or studies in areas defined through the completed roadmaps for action will be launched through grants with Art.36 organisations or procurements. Integration of the results into the regulatory context will be facilitated by establishing trustful and effective cooperation at the EU and international levels. This will allow EFSA to update its guidance, methodologies, and assessment approaches across its scientific domains for higher quality and faster scientific advice, in line with the objectives of its Strategy 2027.

Open positions for Seconded National Experts @EFSA for the - Integrated Data Unit and - Nutrition & Food Innovation Unit

EFSA is looking for Seconded National Experts to fill in two positions, one for the Nutrition & Food Innovation Unit and one for the Integrated Data Unit. The selected candidates are expected to start as soon as possible.

Position for the Integrated Data Unit:

the Seconded National Expert (SNE) will be involved in EFSA activities related to food consumption and food composition data including the activities related to the FoodEx2 classification system.

We are looking for experienced candidates in:

- 1. collection and analysis of food consumption data and/or
- 2. compilation of food composition data and /or
- 3. international food classification systems such as FoodEx2, LanguaL, Codex Alimentarius and
- 4. writing scientific reports in English.

Position in the Nutrition & Food Innovation Unit:

The Seconded National Expert (SNE) will be involved in activities related to generic mandates (e.g. Dietary Refence Values for nutrients) and/or to regulated products' applications (e.g. safety assessment of novel foods, safety and bioavailability of nutrients and nutrient sources, safety/efficacy of other substances in food).

We are looking for experienced candidates in:

- 1. the area of <u>Human Nutrition</u> and/or <u>Novel Foods</u>
- 2. assessment of scientific information through searching, extracting, and evaluating data of data from various sources;
- 3. writing scientific reports in English and reviewing scientific outputs;
- 4. providing technical and scientific support to the activities of the <u>EFSA NDA Panel and its Working Groups</u> (e.g. preparation of working documents, scientific opinions, technical reports; preparing meeting agendas and minutes, etc.).

Candidates who are interested should submit their application via the general call for SNEs (link).

The eligibility criteria for the candidates are the following:

- 1. Be nationals of a European Union or EFTA Member State or a country with which the Council has decided to open accession negotiations and which has concluded a specific agreement with EFSA on staff secondments, except where the Executive Director grants derogation;
- 2. Be employed by a national, regional or local public administration or an intergovernmental organisation;
- 3. Have worked for your employer on a permanent or contract basis for at least 12 months before the secondment and shall remain in the service of that employer throughout the period of secondment;
- 4. Have at least three (3) years full-time experience in administrative, scientific, technical, advisory or supervisory functions at a level equivalent to the post;
- 5. Have thorough knowledge of spoken and written English and a satisfactory knowledge of a second EU language for the performance of the duties;
- 6. Meet the character requirements needed for the duties involved (e.g. a sworn affidavit to the effect that you have no criminal record).

Kindly note that, according to the point 5 of the Article 1 of the SNE rules, the employer shall continue to pay the salary and social contributions to the SNE during the period of secondment while, according to the Article 16, subsistence and monthly allowance are paid by EFSA to cover the SNE living expenses during the secondment.

Postdoctoral Researcher in health risk assessment of endocrine disrupting chemicals in Sweden | 16.09.2022

A position as Postdoctoral Researcher in health risk assessment of endocrine disrupting chemicals is available at Institute of Environmental Medicine, Karolinska Institutet, Sweden.

This project is focused on development of a mechanism-based approach for identifying and assessing the toxicity of endocrine disrupting chemicals that is applicable in the regulatory setting. The project is centered around applying Adverse Outcome Pathway (AOP) methodology to organize, integrate and interpret different types of toxicity data (in silico, in vitro, in vivo and human) and draw conclusions about endocrine disrupting properties of chemicals.
