# Calls

Call for proposals EUBA-EFSA-2023-PLANTS-07- Development of pest survey cards for Union quarantine pests | deadline: 26.09.2023

The deadline for submission of proposals is **Tuesday 26**th **September 2023**.

To be noted that all applications must be submitted through the <u>EU Funding and Tenders portal</u>, following the instructions provided in the call.

#### Hard copy paper applications will not be accepted.

The main objective of this call is to provide a support EFSA in preparing pest survey cards by concluding up to four grant agreements, as indicated under 4 lots:

- Lot 1: Non-EU Acleris spp.
- Lot 2: Non-EU Cicadomorpha, known to be vectors of Xylella fastidiosa
- Lot 3: Non-EU Viruses, viroids and phytoplasmas of Cydonia Mill., Fragaria L., Malus Mill., Prunus L., Pyrus L., Ribes L., Rubus L. and Vitis L.
- Lot 4: Begomoviruses and their vector Bemisia tabaci.

You can find more details (i.e. specific objectives, budget, timelines and examples of the work) in the call documents under the link above.

Eligible organisations applying for this call must indicate precisely in their proposal which lot(s) they are applying for. Organisations can apply for one or more lots. In case an organisation submits proposals for more than one lot, the proposals should be submitted as independent proposals in order to allow independent evaluation of proposals for each lot.

This document re-evaluates the allergenicity of behenic acid from mustard seeds to be used in the manufacturing of certain emulsifiers.

# Info session on MetaPath: how to validate files generated with MSS composers for pesticide metabolism studies | Registration until 27.06.

EFSA is organising the Info Session on MetaPath: how to validate files generated with MSS composers for pesticides metabolism studies, to be held **online** on **June 30**<sup>th</sup> **(09.30-12.30 CEST).** 

Applicants submitting an application under Regulation (EC) No 1107/2009 or Regulation (EC) No 396/2005 are requested to provide data on pesticide metabolism in the areas of residues. These are to be submitted as attachments (xml files), generated with the MetaPath MSS composer software. Member State Authorities receiving the dossier are responsible for the quality check and validation of the xml files submitted by applicants, as defined in the description of the steps to follow to report structured metabolism data in the context of EU applications, available here.

This event aims to support Member State Authorities in validating the xml files generated with MSS composers by applicants and containing pesticide metabolism data from plants and livestock metabolism studies.
