Calls

Call for EU-FORA hosting sites and fellows 2024-2025 | deadline 14.03.

The call for the selection of hosting sites and fellows for the EU-FORA cycle 2024-2025 is open until **14 March 2024**.

The Call intends to fund the placement of 15 fellows by awarding grants to consortia made of two Art. 36 List organisations from two different MS, Iceland and Norway:

- one acting as hosting site and responsible for the training of the fellow, and
- the other as fellow sending organisation, identifying a fellow to be trained.

To further facilitate the creation of consortia, you can either:

- contact your [National Focal Point](#) expressing your interest in this call, either as a hosting site or as a fellow sending organisation. Note that the same organisation can act as both in different consortia, and/or

Organisations can make use of existing joint projects and partners from former projects and EFSA/EU grants. Some of the currently existing large EU projects could be a good starting point for organisations to search for partners.

Trainings

eLearning: In silico models and other relevant modelling approaches | deadline 29.02.

We are pleased to inform you that the EFSA’s training course on “In silico models and other relevant modelling approaches” is now open for registration. This **eLearning** course will introduce the **main principles of different structure based in-silico approaches for estimation of mainly human health toxicological endpoints**.

Participation

The participation is **restricted to members of organisations belonging to EFSA's List of Art.36 Competent Organisations**.

EFSA reserves the right to select the trainees from all registered organisations. Should the number of registrants exceed the available places, the first-come first served principle will be applied. All registrants will be informed about the outcome of the registration and the selected ones will receive credentials for eLearning.

Objective

The acquired expertise will support experts in their **contributions to EFSA's partnership initiatives** where EFSA methodologies are implemented, ultimately contributing to the sustainability and harmonisation of food safety risk assessments in the EU.

Content

In this course you will learn:

- Statistical and rule base quantitative structure activity models (**QSARs**) and how to assess the outcome of these predictions by using expert review.
- **Read-across**, mostly applied in case that the toxicological properties of a data poor target compound is predicted from data rich similar source compounds.
- **TTC** (threshold of toxicological concern) used for unknown compounds occurring at low levels in feed/food.
- Exercises will give the opportunity to train on tools such as the **OECD QSAR toolbox or Vega**.

Structure

The training is composed by **4 modules for a total duration of 6 hours**. Each module consists of one registered presentation and several quizzes. In addition, participants will be supported through online webinars to perform the tests.

Survey: Use of biomarkers of effect in regulatory risk assessment of chemicals | deadline 30.04.

The European Food Safety Authority (EFSA) has initiated a project ([EFSA-Q-2023-00583](#)) towards developing a **guidance on the use of biomarkers of effect in regulatory risk assessment of chemicals**, implemented with the support of a working group of experts established under [EFSA's Scientific Committee](#). The intention is to develop a horizontal guidance to support the risk assessors and to achieve an internationally agreed guidance by establishing consultation and co-creation mechanisms with EU and international organisations, contributing to the [EU Chemicals Strategy for Sustainability](#) and its action on 'One Substance - One Assessment'.

To create awareness regarding the project and to collect input from stakeholders that could support EFSA's initiative, EFSA has developed a [survey](#) to map existing definitions and applications of biomarkers of effect in regulatory contexts in the EU and beyond.

The survey is addressed to different Organisations (e.g. EU Member States and non-EU national regulatory agencies, EU agencies, European Commission services, International Organisations) with a focus on regulatory-relevant activities linked to this topic. The information received from responders will be analysed and used by EFSA for discussion and further elaboration of the feasibility study.

EFSA would very much appreciate your Organisation's input to the survey **by 30 April 2024 EOB**. To facilitate the collection and consolidation of answers within your organisation, a Word version of this survey is included in the survey and available under "Background documents".
