Call for Proposals EUBA-EFSA-2024-BIOHAW-02 on "Animal Welfare: heat stress in livestock during transport" | deadline 31.07.

Objectives:

The aim is the identification of Article 36 organisations to develop and validate an algorithm or model that can predict the effective temperature in a livestock vehicle using the weather forecast and the effect of mitigating strategies such the use of mechanical ventilation and varying the space allowance given to livestock.

The maximum budget EFSA has available is 402,900 € (this type of grant has the form of financing not linked to the costs); the maximum duration of the Direct Agreement is 18 months from the kick-off meeting.

Objectives:

Building on recent improvements, EFSA aims to persist in effectively communicating scientific evidence on zoonoses and foodborne outbreaks by translating it into clear, accessible, and meaningful messages, following a One Health approach to address the diverse needs of audiences. The objective of the contract resulting from this procurement procedure is to **support EFSA in producing the EU One Health Zoonoses report, and in maintaining and updating the related EFSA communication tools** in each calendar year.

Call for Proposals EUBA-EFSA-NIF-2024-01 on "Contribution to the Risk Assessment of Novel Foods and Nutrient Sources in the EU" | deadline 21.11.

Objectives:

With this Call for Proposals, EFSA is launching a new opportunity to involve competent organisations in the assessment of Novel Food (NF) dossiers submitted to EFSA under Regulation (EU) 2015/2283 and the preparation of scientific opinions (specific sections or in full) for the NF regulatory domain.

The objective of this call is to identify and award up to three Framework Partnership Agreements to MS competent organisations or consortia that can provide all the needed capacity and expertise to cover the assessment of entire NF technical dossiers (i.e. expertise in chemistry, microbiology, biotechnology, food technology, nutrition, ADME, exposure and toxicology). Parties interested in participating but with capacity only some of the needed fields are advised to consider **applying in consortium** with other competent organisation(s).

Framework Partnership Agreements will have a duration of 4 years, and a total financial envelope of EUR 3,500,000.
